

### **MUNDOMENTAL® TERMS OF USE**

### 1. Introduction

Mundo Livre Digital Ltd ("Mundo Livre Digital", "we", "our", or "us") operates the MundoMental® platform, a mental health monitoring tool integrated with corporate communication applications. The purpose of the platform is to promote employee well-being by preventing work-related emotional disorders and improving workplace mental health.

By accessing or using the MundoMental® platform, you ("User") expressly acknowledge that you have read, understood, and agreed to be bound by these Terms of Use ("Terms"), which govern the use of the MundoMental® platform and related services provided by Mundo Livre Digital Ltd, a private limited company registered in England and Wales under Company Number 13117572, with its registered office at Innovation Centre, Warwick Technology Park, Gallows Hill, Warwick, Warwickshire, WCV34 6UW, United Kingdom.

### 2. The Service and Use Guidelines

The MundoMental® platform is accessed through the corporate communication system of the contracting company, such as Slack®, Microsoft Teams®, or WhatsApp Business®. The platform uses Artificial Intelligence (AI) sentiment analysis to process users' self-assessment data, identify stress levels at an early stage, and provide real-time feedback and insights.

The processing of users' information, including personal data, is governed by our Privacy Policy, available at https://mundolivre.digital/politica-de-privacidade.

Users are invited to participate in the mental health prevention program initiated by their employer. The employer provides corporate contact information for users who will receive questionnaires related to mental health. Participation in the program implies consent to receive daily or periodic questionnaires and analyses performed by the platform.

Users are solely responsible for the content of their responses to the questionnaires.



Mundo Livre Digital is not responsible for inaccurate or misleading information provided by users. Users must answer truthfully and appropriately to ensure accurate analysis.

Users are strictly prohibited from submitting any written or audio content that is false, harmful, invasive of others' privacy, discriminatory, obscene, offensive, political, or otherwise unlawful or inappropriate. Violation of this rule may result in immediate suspension or termination of access.

Mundo Livre Digital reserves the right to revoke or suspend access to the platform at its sole discretion in cases of:

- (a) Violation of these Terms or of the licensing agreement;
